Penventon Park Hotel collects personal information from you if you register online with us or carry out transactions for goods and services via our website or hotel.

We use the personal information collected for the purposes of:

- providing reservation and booking services for our venues;
- internal analysis, advertising & marketing purposes;
- keeping records and accounts;
- crime prevention and detection (including CCTV at hotel sites).

Data is shared with for marketing purposes and only to third parties, under specific contract terms, whose services we employ to conduct our business and in relation to any supply of products and/or services by us.

Transaction & Information Security

We understand how important it is to securely store any information that you provide. At Penventon Park Hotel we take the privacy and security of your payment and personal details very seriously. Although we take reasonable care to keep your personal data secure, we cannot be held liable for any loss you may suffer from unauthorised access or loss of any data provided to 3rd party websites.

As part of our security measures, we use encryption technologies for online transactions via our websites. You can tell whether a page is secure as 'https' will replace the 'http' at the front of the www.penventon.co.uk in your browser address window. A small locked padlock will also appear either in the bottom bar of your browser window or alongside the browser address, depending upon which browser software and version you are using.

Should you choose to store your credit card details with us via your website user account, for the purpose of making future booking transactions, we will store this information with our secure third party payment gateway which is accredited for PCI DSS (Payment Card Industry Data Security Standards).

- **Full Name** which we collect from you on a legal basis for the Immigration & Hotels Records Order 1972. We store this information electronically on our Hotel System as well as paper records for your reservation, including our arrivals & departures lists, registration documents and our lost property book and/or handover diary if required.
 - We store these details for 3 years electronically and the paper records for 5 years, after the 3 years our Hotel System will automatically remove all of your records. After 5 years all paper records will be destroyed accordingly.
 - Who processes this data- You (when booking online), booking services and Penventon Park Hotel Reception Staff
 - Who has access to this data- Penventon Park Hotel Directors, Manager, Reception Staff, Booking Services/ Computer & Hotel System Support
- **Address including postcode** which we collect from you on a contractual basis. We store this information electronically on our Hotel System as well as paper records for your reservation, including confirmation and registration forms.
 - We store these details for 3 years electronically and the paper records for 5 years, after the 3 years our Hotel System will automatically remove all of your records. After 5 years all paper records will be destroyed accordingly.
 - Who processes this data- You (when booking online), booking services and Penventon Park Hotel Reception Staff
 - Who has access to this data- Penventon Park Hotel Directors, Manager, Reception Staff, Booking Services/ Computer & Hotel System Support

- **Telephone number** which we collect from you on a contractual basis.
 - We store this information electronically on our Hotel System as well as paper records for your reservation, registration documents and our lost property book and/or handover diary if required.
 - We store these details for 3 years electronically and the paper records for 5 years, after the 3 years our Hotel System will automatically remove all of your records. After 5 years all paper records will be destroyed accordingly.
 - Who processes this data- You (when booking online), booking services and Penventon Park Hotel Reception Staff
 - Who has access to this data- Penventon Park Hotel Directors, Manager, Reception Staff, Booking Services/ Computer & Hotel System Support
- **Email address** which we collect from you on an explicit consent basis, we will always ask you for consent to use your email address when booking direct with us over the phone.
 - If you have booked online on our website we will obtain your email address if you have submitted this online during your reservation process, however we will not use this information until we gain your consent on arrival on a consent basis.
 - If you have booked online via Booking.com/ Expedia/ Hotels.com we do not receive your email address from these booking services therefore we collect this information on your arrival on a consent basis.
 - We store this information electronically on our Hotel System for 3 years & **IN TOUCH** online mailing list for 2 years. After this our system will automatically remove your records.

The only exception to this is if you have registered on our website to receive our Monthly Newsletters, we will store your email address on our **IN TOUCH** mailing list indefinitely until you wish to unsubscribe which you can do so on any of the email Newsletters you have received or mark our email newsletter as spam which will add your email address to a suppressed list indefinitely to ensure you never receive our emails.

- **Full card details** which we collect from you on a contractual basis, either to secure your reservation or to take payment in advance.
 - We store this information electronically on our Secure Property Management System server which is accessible via our Hotel System. If you have booked online on any website your card details are stored electronically on our secure Channel Manager website "Siteminder" you can find their privacy policy at:

All card details stored on Siteminder are only stored up until your arrival and 1 day after your departure date. All card details stored on our Secure Property Management System server are retained for 30 days after your departure date. After the 1 or 30 days your card details are automatically removed off both electronic systems.
 - Who processes this data- You (when booking online), booking services and Penventon Park Hotel Reception Staff
 - Who has access to this data- Penventon Park Hotel Directors, Manager, Reception Staff, Booking Services/ Computer & Hotel System Support
- **Other information relevant to customers stay** Reason for stay (Birthday, Anniversary, Wedding etc) Time of arrival. We collect this information from you on a legitimate interest basis.
 - We store this information electronically on our Secure Property Management System as well as paper records for your reservation.
 - We store these details for 3 years electronically and the paper records for 5 years, after the 3 years our Hotel System will automatically remove all of your records. After 5 years all paper records will be destroyed accordingly.
 - Who processes this data- You (when booking online), booking services and Penventon Park Hotel Reception Staff
 - Who has access to this data- Penventon Park Hotel Directors, Manager, Reception Staff, Booking Services/ Computer & Hotel System Support
- **Health / Medical comments or dietary requirements** we collect this information from you on an explicit consent basis.
 - We store this information electronically on our Secure Property Management System as well as paper records for your reservation.
 - We store these details for 3 years electronically and the paper records for 5 years, after the 3 years our Hotel System will automatically remove all of your records. After 5 years all paper records will be destroyed accordingly.
 - Who processes this data- You (when booking online), booking services and Penventon Park Hotel Reception Staff
 - Who has access to this data- Penventon Park Hotel Directors, Manager, Reception Staff, Food & Beverage Staff, Leisure Club Staff, Booking Services, Computer & Hotel System Support

- **Passport** we collect this information on a Legal basis, in accordance with the Immigration & Hotels Records Order 1972. It is a legal requirement for us to gather passport details including your next destination from all non UK residents', we will obtain this for all non UK guests over the age of 16.
 - We store these details on paper records which are securely stored at the Hotel for 5 years, after the 5 years all paper records are destroyed accordingly.
 - Who processes this data- You and Penventon Park Hotel Reception Staff
 - Who has access to this data- Penventon Park Hotel Directors, Manager and Reception Staff.
- **Unique MAC/ IP Address** we collect this information from you on a contractual basis. This data will be stored electronically on a LAN connected computer at Penventon Park Hotel for 30 days, after this time your details will be automatically deleted.
 - Who processes this data- You (the guest) by accepting the Terms of Use of our Wi-Fi.
 - Who has access to this data- Penventon Park Hotel Directors, Manager & Reception Staff, Computer & IT Support
- **Vehicle Registration** we collect this information from you on a legitimate interest basis.

This data will be stored electronically on a LAN connected computer and on a paper registration list at Penventon Park Hotel and only retained during your stay, once you have departed this information is deleted from our computer and paper forms are shredded daily.

 - Who processes this data- You & Reception Staff.
 - Who has access to this data- Penventon Park Hotel Directors, Manager & Reception Staff, Computer & IT Support
- **CCTV Images** we collect this data on a legitimate interest basis for the safety of our guests.
 - This data will be stored electronically on a computer at Penventon Park Hotel and retained for 28 days, after the 28 days the data is automatically deleted off the system.
 - Who processes this data- Penventon Park Hotel
 - Who has access to this data- Penventon Park Hotel Directors, Manager & Reception Staff/ Computer & IT Support

If you have booked via a 3rd party website called Expedia/ Hotels.com your personal data supplied to them during your booking process is not all passed onto us, we only receive your name and number and will collect all other information from you on arrival (Please note when booking with Expedia/Hotel.com you pay them when booking not Penventon Park Hotel therefore we will not have your card details stored)

What Information We Collect And Why: We collect your email address on a legitimate interest basis, by you providing us with your email address and giving us consent to use in order for you to receive our latest news and offers

How Long We Store This Information For: If you have signed up to receive these newsletters you will be on the mailing list indefinitely or until you decide you no longer want to receive them, at this point you simply select 'UNSUBSCRIBE' on one of our email address and all your email address will be added to a suppressions list which is stored on **IN TOUCH** database and retained indefinitely to ensure your email address is not used again by Penventon Park Hotel.

Google Analytics

When you visit our website your analytic data will be stored with Google Analytics, this doesn't hold any person data like name, address or phone number but does use cookies from your computer or mobile device to track the general traffic on our website.
